- 7 The Buyer hereby gives Cape Thoroughbred Sales permission to perform a credit check, should it be deemed necessary.
- 8 The person signing this Application acknowledges and agrees that, to the extent that any information and/or authorisation furnished to CTS in terms of this Application and/or the other documents referred to in 5 above change, become irrelevant or invalid during the course of the validity of the Buyer’s Card in terms of 6 above, he/she shall immediately inform CTS or procure that CTS is informed of such fact and ensure that CTS is furnished, in writing, with any such new information and/or authorisation as may be necessary in order for the prospective Buyer to remain compliant with the requirements for registration as a bidder in terms of the Conditions; failing which a bid received by or on behalf of the prospective Buyer will be deemed invalid.**
